



RE: Non-exclusive, Non-Transferable License

Dear Registrar:

Thank you for being a trusted partner and customer of the products and services offered by VeriSign, Inc. We look forward to working with you and your company and having a long, profitable relationship.

If your partner and customer relationship with VeriSign is through a VeriSign Channel Reseller Agreement (“Reseller Agreement”), you are aware that under Section 9 of this Reseller Agreement you are granted the right to use certain VeriSign Materials, as defined in the Reseller Agreement and in Exhibit A attached hereto, in accordance with VeriSign’s branding guidelines. This Letter Agreement supplements the rights granted under Section 9 of the Reseller Agreement by providing you the VeriSign branding guidelines, and grants you the right to use the VeriSign Materials identified in Exhibit B for the promotion and sales of VeriSign products, goods and services, in accordance with the terms and conditions set forth in Section 9 of the Reseller Agreement, and the terms and conditions set forth herein.

If your partner and customer relationship with VeriSign is through another form of agreement with VeriSign, then this Letter Agreement hereby grants you a license to use the VeriSign Materials identified in Exhibit B, subject to the restrictions set forth in Exhibit A of this Letter Agreement, for the marketing, promotion and resale of VeriSign products and services, in accordance with the use parameters and restrictions set forth in the attached VeriSign branding guidelines.

VeriSign will retain and maintain all ownership rights of all VeriSign Materials, and you agree to use the VeriSign Material in accordance with the VeriSign Branding Guidelines, which is attached hereto and incorporated by reference, and only in connection with VeriSign products and services. You cannot transfer or assign this Letter Agreement, and the right to use the VeriSign Materials, can be cancelled by VeriSign at any time. Finally, we request that you carefully review and use the disclaimer language that is legally required when referring to any third party’s trademarks, URLs, logos, service marks, slogans, copyrighted designs or other brand features. This disclaimer language is outlined in the VeriSign Branding Guidelines, and requires you to alert those viewing any documentation or other material containing the VeriSign Materials that there is no legal affiliation between you and VeriSign and that VeriSign has no responsibility or control over products and services other than its own. EXHIBIT A

Limited License. VeriSign grants to you a nonexclusive, non-transferable, nonsublicensable right and license to: (i) use the VeriSign Materials for the earlier of (a) the term of your applicable agreement with VeriSign, or (b) VeriSign provides you notice that it is terminating your use of the VeriSign Materials. Such use shall be solely in conjunction with the marketing, promotion and resale of the VeriSign Products and Services, You are permitted to modify certain of the VeriSign Materials expressly designated for such purpose by incorporating your trademarks and/or brand features (“Reseller Branding”) in a manner consistent with branding guidelines attached hereto and incorporated herein, and in each case subject to VeriSign’s written approval. All such modified materials will be deemed VeriSign Materials under this Agreement, and owned by VeriSign, provided however, that VeriSign shall have no rights to the Reseller Branding. VeriSign grants no right in the VeriSign Materials or in any other materials, trademark, trade name, service mark, business name or goodwill of VeriSign except as licensed hereunder. You agree that you will not, at any time, assert or claim any interest in or do anything that may adversely affect the validity or enforceability of the rights in the VeriSign Materials or any other materials, trademark, trade name or product designation belonging to or licensed to VeriSign (including, without limitation registering or attempting to register any trademark or copyright incorporated in the VeriSign Materials, other than the Reseller Branding). “VeriSign Materials” means information provided by VeriSign, in the attached Exhibit B, consisting of sales and marketing materials related to each of the VeriSign Products and Services, for use in promoting, marketing and selling VeriSign Products and Services under this Agreement.

No Confusing Use. You shall not use any trademark, trade name or product name confusingly similar to a trademark, trade name or product name of VeriSign.

No Continuing Rights. Upon expiration or termination of this Agreement, you will immediately cease all display, advertising and use of all of the VeriSign Materials and will not thereafter use, advertise or display any trademark, trade name or product designation which is, or any part of which is, similar to or confusing with any VeriSign Materials (excluding Reseller Branding) or with any other materials, trademark, trade name or product designation associated with VeriSign or any VeriSign Product.

Translated Versions. In the event that certain of the VeriSign Materials are required to be translated into another language, you understand that you are responsible for the accuracy of the translation and liable for any omissions or errors in the translated material, and shall defend, indemnify and hold VeriSign harmless for any claims, allegations or liability that result from the reliance on such translated materials, either by you or a third party.
